CPC (Brian Curry is Chair of the Community Planners Committee Subcommittee for Alcohol Licensing & Neighborhood Code Enforcement) The CPC voted 23-0 to approve the recommendations below to the Planning Commission to offer a framework for possible amendments to the Municipal Code, Council Resolution R-294124, public noticing; possible changes in city processes in alcohol licensing; and new ideas regarding regulating existing businesses:

- · Recommend the city institute land use policy with respect to alcohol licensing seeking local control via Conditional Use Permits (CUP) and Deemed Approved Ordinances (DAO)
- · Recommend a fee structure for education, compliance, and enforcement
- · Recommend a cost benefit analysis (tax, fines, and fee revenue versus the cost of city services for enforcement)
- · Recommend a review of existing municipal models (e.g. City of Ventura) which includes CUP, DAO and fees
- · Recommend re-examination of Municipal Code Section 141.0502 (paragraphs b & c)
- · Identify and solicit input from all stakeholders

8. Palisades Park Comfort Station Update (Possible Action Item)

Presenter: Ali Darvishi (City of San Diego Public Works Senior Engineer)
Broke ground on the Comfort Station on Feb 19th, the low bidder was disqualified after 3 months. Work is supposed to finish by mid-late May but it is behind schedule. There are two options now to finish the work. If work stops for the summer moratorium from Memorial Day to Labor Day, the project will be complete in November. If work continues through the summer

moratorium, the project will be complete by August 25th.

Deborah Conca made a motion to continue construction through the summer moratorium with conditions that the shower is working, a minimum of 4 port-a-potties provided and the PBPG is requesting additional permanent bike racks to be installed, Scott Chipman seconded, **Motion passed 18-0-0**
