## 6. Government Office Report: (Informational Item)

Nica Bukalova, Chief of Staff for Council District 2, spoke on budget review, final budget decisions will be made on June 9<sup>th</sup> or 10<sup>th</sup>. Ed Harris requested money in the budget for traffic engineer to review projects, \$20k to assist planning groups with outreach, and money for urban tree management. The city has started receiving applications for Medical Marijuana CUPs. 19 applications in District 2 have been received in industrially zoned areas. No CUP's have been issued yet but are in review and could be issued in 6-months. Bike to Work Day this Friday. Ed Harris is holding community coffees alternating through all neighborhoods in District 2. The first one is this Saturday at 9am in Ocean Beach at the Coffee Method at 4993 Niagra Ave. There is a state program to assist businesses to install electric charging stations on their property. Questions:

**Scott Chipman:** 9 stores selling marijuana currently in Pacific Beach, why is it so hard to shut them down?

Answer: In neighborhood code compliance process now.

**Chris Olson:** Safe routes for kids street murals, submitted today for permit, \$576 plan review, \$600 for permit. The community is paying the city for a permit to beautify the public space and increase safety. Can the city help reduce this fee?

Answer: Will report back.

Don Gross: Update on DeAnza?

Answer: No update.

Public Comment: Mission Blvd & Hornblend flashing crosswalk appreciated

Brian Curry: OVO update?

Answer: Will go into effect in July.

Joe Wilding: Why are signs necessary for Oversized Vehicle Ordinance? Answer: Municipal Code, could consider adding them to existing signposts. Paul Falcone: Change in district, but no change in funding needs for CIP

Answer: Will discuss offline top three projects.
