The State is serious about homelessness and sending funding to cities and counties

Could be anywhere from 750 Mil - to several billion. It's up to the Council to see that the funding goes where it should. SB50 failed for now. Another version is expected to be introduced and I'm aware of the problems you've raised.

A - dollars are spread statewide to 54 counties and past poor spending is a problem

Q - what are you doing to improve transit performance?

A - I've supported more funding but you need to make sure the City is spending the funds properly

Q - Would you enforce existing code that Short Term rental are illegal and bring the housing back to the community?

A - yes and if people disagree with it then they need to change the law

Project #646124: 853 and 855 Sapphire St.

Presenter: Daniel Linn

Coastal Development Permit for the demolition of an existing structure on two lots, and the construction of two dwelling units as follows: a 2,611 SF three story units with garage and decks at 855 Sapphire and a 2,331 SF unit with garage and decks at 853 Sapphire St. The 0.15 acre site is in the RM-1-1 Coastal Height limit, Coastal Non-Appealable area, Parking impact/Coastal Impact Area).

ITEM 8: Mid-Coast Trolley Update - Pete d'Ablaing

Lots of parts happening now; grading, retaining walls, bridge work and track work, catenary poles, signals etc. Trends on schedule, "within budget." 52% is TransNet funding

Starting March 1st there will be I-5 nighttime closures due to bridge installation. KeepSanDiegoMoving.com

Q - I asked last time how much funding was voted for this project in the original Transnet and we haven't heard yet

A - Sorry I didn't get back to you

Q - What about the renaming of the trolley station?

A - I gave the petitions to the MTS director and staffer Roc Chutes (?) is now taking it up

Q - public art?

A - We're working on it and generally we need folks to pay to install and maintain but we are open to it.

Q - what about bike path improvements near the station?

A - I think it's happening I have to look at the plans

Q - any proposals for last mile services? shuttles?

A - ask Marissa Mangen

JB - I've spoken to her many times and SANDAG loves the idea but it's an issue of funding and MTS has listed it as a priority connection to the beach. We need to push.

ITEM 9: Streets & Sidewalks Subcommittee - Eve Anderson

- Traffic light timing on Balboa at I-5 exit ramp near trolley station project

We think it's been changed. SC will re-time it.

- Dedicated parking for lifeguards at Grand Ave

The City appears ready to paint spaces to set aside on Hornblend. CVS is the only property owner that has to sign-off on this. They want to take angled spaces and straighten them and this adds six spaces

MOTION EA/PG to support proposal for new parking for lifeguards on Hornblend as presented.

MOTION to add that they be allowed for public use after hours. Amendment agreed to.

ALL in FAVOR, Chair not voting

Q - how will lifeguards ID their vehicles? Tags or what?

A - not sure- they now usually leave lifeguard patches on their dash but something else should be done

### 7:30pm

- Traffic issues on Foothill Blvd

2-land major road - 20% of all trips in and out of PB are via Foothill

From Beryl to Fanuel - no ped crossings

Long range plan is roundabouts at Loring (in design), at Vickie (maybe) and at Tourmaline

Circulated petition for traffic circle at Vickie & Foothill (neighbors within 200 ft need to support)

Contacted 18 homes and got 14 in support (78%). Should get one or more to show that it's very supported. It's very important to slow traffic along this street and also working with flashing pedestrian crosswalks.

#### **Public Comment**

Kristi Stoza - supports Proposals

Judith Wesling - I live at 4958 Foothill between Loring and Beryl. I want to ask that the turn be very tight so that people can't just power through the roundabout. Are there other crosswalks going in? The sidewalk is very close to my bedroom and I'm concerned there's going to be a flashing yellow light and I don't want that to happen.

EA - Not sure - until the traffic slows down, it's too dangerous

EA presented "Foothill Blvd Proposals"

Problems: Excessive Speed, Ped safety/lack of crosswalks, Difficulty for vehicles entering Foothill from Vickie Dr; Blind Intersections; Cardeno-Fanuel-Foothill - poorly designed intersections, Dangerous to PB Elementary students and parents; Bike lanes, not visible enough

Solutions: (see handout from Streets & Sidewalks)

Q - when are accidents happening? Seems like it's when drivers are blinded at sunrise or sunset and traffic calming may not help that

MOTION MB/JB to recommend "Excessive Speed" Solutions (Signage: School Ahead, 25 MPH Zone" near Fanuel in both directions; Flashing lights 175' before Fanuel in both directions; Flashing lights, both directions, Loring and Foothill; SPDP speed survey, after traffic calming measures are enacted) and any others the City comes up with ALL in Favor Chair not voting

MOTION MP/EG to recommend "Pedestrian safety/lack of crosswalk" Solutions (A pedestrian-activated flashing beacon is slated to be installed within six months, law enforcement near the shcool, Enforcement of illegal turning at Loring) and add consider other safety ideas for Beryl All in Favor Chair not voting

MOTION JB/BD to recommend for 'Difficulty for vehicles entering Foothill from Vickie Dr" Solutions (Narrow the wide space on Foothill just east of Vickie Dr; trim obstructing plants to the west, long range, a roundabout is needed) All in Favor, Chair not voting

MOTION MB/EG to recommend Solutions for "Blind intersections" - Add/Increase red curbing and trim plants to improve visibility.

All in Favor Chair not voting

MOTION JB/SP to recommend solution for "Cardeno-Fanuel-Foothill intersection / Dangerous to PB Elementary": Suggest that all lights turn red when pedestrians initiate lights or any other solutions that Traffic Engineering can come up with . All in Favor, Chair not voting Note: Mainly at school times are the problems.

MOTION PG/SP to recommend Solution to "Bike Lanes, not visible enough" - paint them green for greater visibility All in Favor, Chair not voting
