Update: Do not have the final draft of the ordinance yet. PBPG drew the line at capping by district rather than for the whole city. We will have minutes from the Planning Commission (PC) meeting. The PC board member will attend the City Council meeting.

Ocean Beach: They identified "platform accountability" as their number one priority. SF platform identifies that platforms can only list those with documented licenses. The platforms can be fined if they list without the documentation. This would ensure that Airbnb would work with the city rather than against it. There is also the idea of distance separations that would spread them out to protect community character. Also identifies requirements for distance separation and occupancy limits.
