Alec Phillipp: City Public Works: Construction on Sewer Group 827 by Golf Course on Grand and Figueroa. Still need to find sewer lines. Traffic control TBD. Westbound traffic on Grand will be restricted. Notifications out. Ingraham projects. Hoping to be done by Memorial Day. Some work will be finished after Memorial Day. Will need waiver for

Karin Zirk: Friends of Rose Creek. Providing feedback for SANDAG. Got a permit to destroy creek. Crushed stone being placed there and moving from intended location.

Chris Olsen: Been involved since 1985. Brian Curry has done the best job. PB EcoDistrict setup at this time.

Don Gross: Top 15 deadly intersections: 3 are in PB. Cass and Garnet. Crown Point Dr. and Fortuna.

Mike Beltran: Wanted to run again but thinks the requirements for elections are too much. Doesn't think 25 signatures are necessary. Stepping down as traffic chair.

Lou (Band-aid): Shouldn't be shocked PB is 2nd in crime.

Marie Beckett: April 29: PBTC graffiti clean-up. 9am- Noon. STVR issue: This Friday smart growth and land use committee meeting at Jacob's hall. Listening to ordinances to allow vacation rentals.

Jordan Beane: running for District 2 council member. Came from upstate NY. Worked for Chargers since 2012. Jordanbeane.com. Wants to fight for Monarch butterflies. 96% population decline in 20 years. Grow milkweed in your garden.

Sara Berns: annual Dinner Thursday March 30. Tickets available. Casino night dinner on William B Evans sternwheeler. Needs two members to parking committees and 2 members for special events committee. Also needs an at large committee member for the special events committee.

Gary Wonacutt: President MBTC. Regarding Smart Growth meeting this Friday. 12,000 STVR listings. 370 sq miles. 1,600 rentals in MB, 220 acres. Proposing splitting ordinance for inland and some separate rules for West of the 5. Has a template for MB that other planning groups can use.

Presenter: Brian J. Curry – Last Chairs report after 6 years. Alcohol ban at beach. De Anza cove. Balboa Transit Specific Plan. Incredible opportunity. Pushing for sustainable design in projects. EcoDistrict guiding principles. Everything sustainable. PB Pathways. Stressing pedestrian and bicycle priority over vehicular traffic. North PB lifeguard station design. Also boardwalk improvements in that area. STVR – formed subcommittee and made recommendation to the city. City attorney now agrees they are illegal. Beach and Bay YMCA at the middle school. \$3m in seed money, needs \$15m total. Lease for \$1/year from middle school. Now they need to raise money.

Brian Curry: Chair since 2012. Tireless advocate. Got a proclamation to make March 22 Brian Curry Day! Street light audit: audit shows dept doesn't operate efficiently. Standard is 12 days. We don't repair in less than a month. Some are as old as 1929. Operations not standardized, no inventory, no automatic ordering. Working on traffic problems. On Monday – Myrtle Cole had homeless policy meeting. SDSU, Mayor's office presented. Short term and long-term goals. Councilmember is concerned with prop 47 (early release of prisoners). Stacie Spector. STVR meeting this Friday. 3 draft proposals on-line.

Improving La Playa and Ingraham intersection for pedestrians.

3 deviations for set-back issues. Will generate 50% of energy from photovoltaic. Chargers for electric cars. Many other features. Not LEED certifying.

Kristen Victor: wants more affordable housing. Wants space for teachers and firemen.

Peter Lee: LEED certification means paying money for a plaque on a wall.

Chris Olsen – Street art off alley. Prefers 1-2 bed. Not 3-4 bed. Wants affordable housing. Motion to approve with alley street lights. 1st. Jason, 2nd Baylor. Approved. 7-5-0. Tony Franco – wants more offices upstairs, Paula – no affordable, Eve -, Joe – didn't like it, Jim – too many bedrooms

Jim – Motion to extend meeting until 8:45pm. Ben recused. Tony Franco, Marcia Nordstrom and Debbie all left.
